- Games will consist of two, 20-minute halves. The clock will run continuously except for the last 2 minutes of the game. **During the running clock periods, officials will signal for the clock to stop immediately when a time out is called.** Overtime periods will last for 2 minutes. The last 2 minutes of the game and all overtime periods will be run in accordance with KSHSAA Basketball Rules.
- Teams will be allowed 4 time outs per game. One additional time out per overtime period will be allowed. Remaining timeouts can carry forward into any and all subsequent overtime periods.
- If there is a 15 point or more lead during the last 2 minutes of a game, the clock will run continuously. Once a 15-point lead during the last 2 minutes of a game has triggered the operation of a continuous clock, the clock will continue to run continuously even if the lead becomes less than 15 points.
- KSHSAA Basketball Rules will apply in all instances unless specifically noted above.
- Division championships will be played as follows: High School boys and girls divisions (eligible athletes must not have officially graduated from high school or be 19 years of age or older as of 3-26-2010) and Adult men and women divisions (open to all possible participants regardless of age).
- Individual medals for each division championship team.
- All proceeds will go directly to the BLHS girls and boys basketball programs.
- A daily admission fee will be charged as follows: **\$3.00 for adults and \$1.00 for students with pre-school children admitted for free.**
